RE: Reuse of Draper School 1

Dear ANC Commissioners:

In accordance with section §10-801(a)(4) of the DC Official Code, this letter serves as notice that the District of Columbia Department of General Services ("DGS") has determined that the Draper School located at 908 Wahler Place, SE Washington, DC (the "Property") is surplus. The Department of General Service will be holding a community meeting regarding the reuse of the Draper School. The meeting will take place at 6:30 p.m. on Thursday April 30, 2015, at Achievement Preparatory Academy ("APA") located at 908 Wahler Place, SE Washington, DC 20032.

By law, the District is required to give public charter schools the Right of First Offer on District of Columbia Public School ("DCPS") properties that are no longer needed for the purpose of operating a DCPS program. Further, existing Charter Schools tenants that have occupied all or substantially all of the facility or property have a preference in selection as tenants for the leasing of surplus school properties. In implementing this process, we want to ensure that input from the community is incorporated in this decision. We also want to share analysis we have been provided by the Office of the Deputy Mayor for Education on the population projections, existing public and public charter school programs, and projected need for specific programs in the area. Our goal is to ensure that the right school programs are targeted to the needs of the community based on this data analysis and public input we receive at the hearing.

Accordingly, the District is also considering providing a new lease for the Property with APA. We need your help to ensure a broad participation at this community meeting. Please assist us in spreading the notice and join us on April 30, 2015, for this important conversation with your constituents.
